

# Public Input on Changes to Standards for Septic Systems near Impaired Water Bodies in Imperial County

## COMMUNITY MEETINGS

The Imperial County Public Health Department's Environmental Health Program has initiated a public comment period on its draft Local Agency Management Program (LAMP) document for septic systems. Three public community meetings have been scheduled where staff will review the regulations and collect feedback and comments from the public. Owners of existing septic systems will need to continue to meet current standards; however those adjacent to an impaired water body who install a new or replacement septic system or have an existing system that has failed may be required to comply with enhanced protection standards.

### Topics:

Which areas of Imperial County will be affected?

Changes to the current rules for septic systems.

### Who should attend?

Property and business owners with installed septic systems, developers and owners of local construction companies and interested members of the public.
